Dues and Payment Information

ACMLA's fiscal year runs from July through June. Membership dues include the cost of one monthly lunch per member firm. Additional people within the same firm and guests are also welcome to attend meetings with payment on a per-meeting basis or a discounted annual dues rate. New members joining at various times of the year may be eligible for pro-rations of dues as determined by the board.

Annual Dues: Invoices are sent during July each year for the annual dues which are currently \$550.00 and are due prior to the September meeting. Additional members from the same firm are currently \$500 each.

Application Fee: \$100 (waived for individuals who were members of a previous firm). This application should be accompanied by a check made out to ACMLA in the amount of the application fee. New members will be invoiced the remaining amount due when their membership application has been approved. Payment may be made at any regular meeting or by mail. Checks, or credit cards are accepted.

Meeting Schedule

Monthly meetings are held from August through May and are on the 2nd Tuesday of those months. There are no meetings in June or July. Members are also encouraged to join committees that may have additional meeting times.
